Each exam end time includes any breaks during the exam as prescribed by the professor. If your final examination has been rescheduled, you should be able to view your examination information in PROWL and should receive that schedule in your Loyola Law School email will appear in your PROWL account. Exam Tips Before the Final Examination Period Begins

1. It is extremely important that you test the examination software “SofTest” on your computer before you sit for your exams. This will help to significantly reduce any chance of you having a problem in the examination room. The test file recommended is named Survey_2016-2017. The passcode for Survey_2016-2017 is 1234567. One of the best ways to test your computer is to type a paragraph in SofTest, copy the paragraph and then paste it many times in succession. This will stress your computer beyond the typical typing speed. If you don’t have any problems, then you are successful. If you have a problem, please contact the Helpdesk in the Computer Resource Center, which is located on the second floor of the Rains Library.
2. Download your examination answer files as soon as they are ready. Don’t wait until the day of the exam as you will need an internet connect to download the examination answer files. We will notify you as soon as they are available for download.
3. If you are using SofTest to complete a take home final examination, plan you time wisely as SofTest will not allow you to open multiple examination files at the same time.
