The Restorative Justice Conference is intended for survivors of human trafficking who are interested in learning more about restorative justice and contributing to the development of an alternative response to justice. Through this conference, we aim to center the voice of survivors in a proposal to fund a pilot program in Los Angeles County that utilizes a restorative justice approach in human trafficking cases. Survivor leaders will be compensated \$400/day for their time.

Our goal is to open this opportunity to 10 survivors with lived experience from the greater Los Angeles area who have a demonstrated history of advocacy within the anti-trafficking field. Survivor Leaders currently serving in positions of leadership are highly encouraged to apply.

The answers you provide in this form will assist us in the selection process to participate in this event. We expect to notify survivors by (enter date) whether they have been confirmed to join us.

Confirmed participants will be provided with a stipend of \$800 (\$400/day) for attending *both* days of the conference. Participants will also be required to attend a Zoom Meeting on (enter date) in preparation for conference.
