- Yide Ma is the President of Zhongguancun Intellectual Property Strategy Research Institute, a vice Chairman of China Intellectual Property Law Society, a professor at the School of Intellectual Property of Renmin University of China, a professor, researcher and PhD supervisor of the Center of Intellectual Property Law Research of Zhongnan university of economics and law which is the Key Research Institute of Humanities and Social Sciences in Universities set by the Ministry of Education and the Research Center for national protection of Intellectual Property Rights, a researcher at the Beijing Academy of Social Sciences, an arbitrator of China International Economic and Trade Arbitration Commission, a special supervisors of The Supreme People's court, a consultant for Samsung's Global Intellectual Property Strategy, and a committee member of Central Legislative Affairs Committee of China Zhigong Party.
