

Schedule for Final Exams Originally Scheduled as In-Person Exams, Now Being Administered as Take-Home Exams

Fall 2020 Final Examinations

Due to COVID-19, **ALL** in-class proctored exams are now open-book, take-home, and non-proctored. Students will now need to download, complete, and upload their exam file on the originally scheduled exam date (see subsequent pages for 2020 Fall final examination schedule). Exam files will be available for download starting at 7:00 a.m. Pacific Standard Time (PST) on the day of the exam date. Your professor will let you know how much time you have to complete the exam. You must upload your completed exam by 11:59 p.m. (PST) on the exam date.

Your individual exam assignments will be viewable in PROWL by Tuesday, November 17, 2020. You will receive an email to your Loyola Law School email account when they are available in PROWL. Any rescheduled exams will be noted in PROWL; you will also receive an email.

How To View Your Exam Schedule

2. Click on the **Student Services** tab
3. Click the **Registration** link
4. Click the **My Exams** link

Before the Start of the Examination Period

1. **Download and test the examination software [Exemplify](#)** to minimize problems during your exam. The test file is “Mock-Take-Home-2020-21” (the passcode is LOYOLA1). You will have 10 downloads to fully test the software. **Tip:** Type a paragraph in Exemplify, copy the paragraph, and then rapidly paste it many times in succession. This will stress your computer beyond the typical typing speed. If you notice any issues, contact ExamSoft Technical Support at (866) 429-8889 (Option #3). 2. **Read the [Exemplify instructions for Take Home Exams](#).**
3. **Download your exam files only when you are ready to begin.** An Internet connection is needed to download and upload the examination files.
4. **Check your Loyola Law School email account daily** during the examination period to avoid missing important notices.
